Background

The Water Research Commission's (WRC) mandate is to conduct and manage research in the water and sanitation sector. This includes moving research to practical innovations and solutions aimed at solving the country's key water and sanitation challenges and inform decision-making. More recently, the WRC has concluded its strategy for the next five years, 2023 to 2028 with a shift towards measuring outcomes and the impacts of those. One of the key outcomes on the WRC strategy is that of ensuring a technology driven water sector, an empowered and influenced stakeholder as well as water security through adaption and resilience. The WRC has embarked on a stakeholder centric approach which will be ensuring that water and sanitation research and innovations done through the Commission benefit and address the identified stakeholder challenges. A WRC team has been delegated to do pre-engagement sessions in Mpumalanga Province to establish the required research-based solutions and interventions to address the identified key challenges.

The purpose of the workshop is to meet with stakeholders responsible for managing water and sanitation related projects and researchers and discuss broadly and explore joint interventions based on current and past WRC projects.
