### **TERMS OF REFERENCE / SCOPE OF WORK**

#### **1. BACKGROUND**

The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

#### **2. SCOPE OF WORK**

To enable the WRC to deliver documents in a timeous manner, various documents and assets need to be couriered in the following areas:

- Nationwide, including outside major centers of South Africa
- Africa
- International

For this purpose, the following services are required for documents or assets to be collected from and delivered at any office of the WRC:

**Same day delivery:** A door to door express service where collection is made from any office of the WRC immediately after a call has been made and delivered the same day to its destination

**Urgent pre 09:00 delivery:** Where urgent documents or assets need to be delivered before 09:00 the following morning.

- iii. WRC Supplier application form must be completed and signed (copy attached)
